## OUR AMBITIONS, OUR TASKS

Our tasks are to assist and support economic operators to support economic recovery and the ecological transition of French sectors.

By 2020, our ambition is that enterprises in the agriculture, agri-food, forest/timber, horse and bioeconomy sectors should be recognised as the green and innovative driving force of the French economy. This should lead to increased production and market share, the creation of new products and services, and hence jobs, and increased exports.

We are pursuing four strategic objectives for the period 2015-2020 :

- ▶ boost economic activity and employment ;
- ▶ increase the competitiveness of enterprises by improving their economic and environmental performance ;
- ▶ improve the quality of the service provided to enterprises, sectors and local authorities ;
- ▶ create a working environment which is conducive to accountability, collective work, partnership and commitment.

# OUR STRENGTHS

Naturally, this reorganisation relies on our many levers and strengths. Above all, our ability to unite, **mobilise and bring together our partners**.

We also have strong expertise in many fields, such as economics, the environment and negotiations, etc.

Another of our strengths is our presence and **influence in Europe and throughout the world**.

Finally, we can build on our regulatory powers and significant financial resources: €10 billion in EU funds and €1.8 billion from the national budget.

This ambition, these objectives and these resources must therefore enable us **to be a directorate serving enterprises, sectors and local authorities**, but also and above all an effective, proactive, innovative, inspirational and flexible directorate.

We carry out our core tasks in accordance with the rights and duties entailed by public service. We also endeavour in our daily work and in our dealings with our partners to embody the following five values: innovation spirit, cooperation, integrity, openness and commitment.

# OUR ORGANISATION

Our structure comprises 2 delegations and 4 departments.

The **Ministerial Delegation for Agrifood Enterprises** is an interface with external partners, industry representatives and enterprises, which complements and provides support to the departments.

The **Ministerial Delegation for French Overseas territories** coordinates and implements overseas policies on agriculture, food and forestry. It works closely with the directorate's departments, the other departments in our Ministry, ODEADOM (Office for the development of the agricultural economy in the French overseas territories) and the other ministerial departments.

The **Department for Sectoral Development and Employment** covers agricultural and agri-food production, horses, forest/timber and bioeconomics. It works with enterprises both upstream and downstream and builds on the diversity of these sectors.


The **Department for Competitiveness and Environmental Performance** brings together all activities related to sectors, regions and local players. It aims to raise the profile of the services offered to economic operators, ensure a consistent approach across sectors and systematically combine economic and environmental performance, which have for too long been opposed.

The **Europe and International Relations Department** aims to make better use of European integration and the globalisation of the French economy, to win new market shares in Europe and the rest of the world, and to play an active part in the decision-making process in Europe and across the world to promote France's economic interests.

The **Governance and CAP Management Department's** main tasks are to eliminate the risks of financial corrections, secure expenditure and improve the directorate's internal operations by promoting innovation, networking and experimentation.

## OUR PRIORITIES FOR 2018

- ▶ **Ensure adherence to the timetable for CAP support payments for 2016 and 2017** plus a return to the usual timetable for 2018 support payments (first and second pillars) while also ensuring security for public expenditure.
- ▶ **Implement the recommendations and decisions reached** during the French General Food Conference, fostering continuation of its mindset and collective dynamic in all sectors.
- ▶ **Speed up the adaptation of tools for the support of companies** in conjunction with the decentralised services, central government operators and our partners in order to combine more effectively economic and environmental high performance in the agricultural, agrifood, bioeconomy, forestry and wood industries.
- ▶ **Promote France's position on the future CAP**, immediately engaging a process of reflection on the implementation of the future CAP in France, notably from the standpoint of its instruments and administrative organisation.
- ▶ **Manage the national roll-out of the changed criteria** for areas facing natural constraints in order to arrive at a revised, validated national framework to be in place by the end of 2018.
- ▶ **Implement the Ministry's roadmap** for the deployment of the climate strategy and contribute to improving the quantitative management of water in agriculture.
- ▶ **Roll out in the agricultural, agrifood and forestry sectors the law** on government to underpin society's confidence in public action.
- ▶ **Strengthen protection of soils and agricultural land** by preparing a roadmap with the partners.
- ▶ **Contribute to protecting the interests of our companies in the context of Brexit** and trade negotiations with the EU.
- ▶ **Finalise and deploy the Europe & International strategy** of the Ministry of Agriculture and prepare the way for France's chairing of the G7 Agriculture ministerial meeting.
- ▶ **Ensure the optimisation of the budgetary and human resources** of the DGPE and its partners (decentralised services, operators) from the standpoints not only of programme 149 resource management but also consideration of Public Action 2022.
- ▶ **Implement our 2018 work programme in accordance** with the DGPE's charter of values and commitments, channelling the talents of all to achieve collective success.
